The BCLA fisheries subcommittee continues to partner and work with the DNR to monitor the health and population of the various fish species in Big Cormorant Lake. We have been working on some joint projects with the DNR and are happy to report that our lake is generally in good shape with most classes of walleyes and other species in the appropriate ranges. Pollution of our lake poses the biggest threat to the fishery. As a reminder, please do not use any phosphorus fertilizers on your yards and use caution when filling gas in your watercraft to prevent spillage.

COLA

We had our first COLA meeting of the year on April 12th. RMB Environmental Labs in Detroit Lakes discussed the continuing process of monitoring lakes for positive and negative trends to help lake associations head off potential problems with lake water quality. They have a great website with a tremendous amount of information on the area lakes for anyone who is interested. The website is <u>www.rmbel.info</u>. COLA has stressed and written letters of concern to Becker County about old septic system inspections. Becker County is going to start rotational septic inspections beginning with septic systems that are more than 10 years old. They will start with the lakes that have the worst TSI (Trophic Status Index) first. It will be a long. slow process, but it is at least a first step. COLA is asking for all Lake Associations to continue to push Becker County on this issue to get septic systems up to date.

4th of July Boat Parade

The annual 4th of July Boat Parade is on again! Don't miss this opportunity to show your patriotic spirit. All boats are welcome, decorated or not, to tour the lake together. We will meet on Wednesday, July 4th, at 11:00 a.m. in front of the north shore boat landing. We hope to see you there!
